CONFERENCE CUSTOMS REGULATIONS INFORMATION

Under Bahamas Government regulations, special concessions are made to groups bringing goods into the country provided the procedures are followed explicitly:

1. An itemized list of goods typed on your letterhead with a dollar value for each item.
2. Upon receipt of this information, approval is requested of the Bahamas Government by Atlantis on your behalf to grant permission to bring in goods without payment of import duty. If this list is not received within 14 days prior to the show, we cannot assure exemption from import duty.

An average duty is 52% of the value of the item

SPECIAL NOTE: Some items cannot be exempt from import duty and include:

- Food and beverage items
- Suntan lotion and sunscreen
- Golf Balls

3. A copy of this itemized list of goods with the dollar value and all other information requested must accompany the shipment.
4. Upon arrival in Nassau, a licensed custom's broker must clear all items. They are provided with the authorization we receive from the Bahamas Government to allow your goods into the country. No goods are permitted into the country unless accompanied by a broker or items will be subject to import duty and/or seizure. There is a fee for these brokerage services, which is included with your shipping bill.

If you intend to hand carry your supplies as luggage, Atlantis will still need to receive your itemize list 14 days prior to your arrival along with your arrival date, flight number and time of arrival. Arrangements will be made to have a custom's broker meet you at the airport and assist you with clearance through Bahamas Customs. This is a special service and doubles the normal broker rate. If this procedure is not followed, the Bahamas Customs Department can detain your items and they may be subject to duty.
